## **TARIFF**

### **1.1 Freight from arrival Hong Kong Airport up to Cold Store at Qingdao International Exhibition Center**

1 kg to 40 kgs – US\$640.00 per AWB per exhibitor  
41 kgs to 60 kgs – US\$760.00 per AWB per exhibitor  
61 kgs to 100 kgs – US\$1,040.00 per AWB per exhibitor  
101 kgs to 150 kgs – US\$1,520.00 per AWB per exhibitor  
151 kgs to 200 kgs – US\$1,960.00 per AWB per exhibitor  
201 kgs to 250 kgs – US\$2,360.00 per AWB per exhibitor  
251 kgs to 300 kgs – US\$2,740.00 per AWB per exhibitor

**For consignment exceeding 300 kgs, additional charge US\$4.00 per kg**

**AIRFREIGHT VOLUME/WEIGHT RATIO 6:1 (WHICHEVER YIELDS GREATER REVENUE)**

Airport terminal fee, airlines documentation fee, agency fee and airport storage charges will be charged accordingly at cost.

#### ***SERVICES PACKAGE FOR 1.1 INCLUDES :***

- a. Pick up of freight from Hong Kong Airport to cold-storage in Hong Kong for consolidation.
- b. Delivery of freight from Hong Kong to Qingdao port by refrigeration container.
- c. Delivery of freight from Qingdao port to Qingdao International Expo Center.
- d. Cold storage at Qingdao International Expo Center

### **1.2 Delivery of Frozen/Chilled seafood from Cold store to exhibitor's booth**

- US\$110.00 per exhibitor for seafood samples under 300 kgs.

For consignment exceeding 300 kgs, additional charge US\$40.00 per 100 kgs

## **TARIFF FOR FROZEN/CHILLED SEAFOOD TO QINGDAO VIA HONG KONG BY AIR**

- 2.1 Freight from arrival Hong Kong Airport for delivery to cold storage at Qingdao International Exhibition Center – US\$9.60 per kg, min. 40 kgs per exhibitor per consignment

Airport terminal fee, airlines documentation fee, agency fee and storage charges will be charged accordingly at cost.

- 2.2 Qingdao Airport terminal service charge – US\$0.60 per kg, min. 100 kgs per consignment

- 2.3 Reefer truck fee in Qingdao – US\$250.00 per consignment

# ADDITIONAL CHARGES FOR FROZEN/CHILLED SEAFOOD

## CUSTOMS AND CLEARANCE FEES

1. Customs clearance fee in Qingdao - US\$100.00 per consignment per exhibitor
2. Customs inspection fee in Qingdao – US\$100.00 per consignment per exhibitor
3. Hygiene inspection fee in Qingdao - **US\$220.00** per consignment per exhibitor
4. Quarantine fee – US\$25.00 per package
5. Disposal of seafood (after daily show closed) – US\$1.00 per kg, min. 80 kgs
6. Qingdao International Expo Center management fee  
-US\$0.50 per kg, min. 100 kgs per consignment per exhibitor
7. Surcharge on frozen seafood (by seafreight) handled after **21 Sep., 2022**  
- 30% of normal rate

## **\*\*REMARKS:**

Due to the COVID 19, the China CIQ will NOT allowed any kind of TASTING the seafood samples which shipped directly **from Overseas** to the EXPO.
